Introduction

Centriprep® centrifugal filter devices are disposable ultrafiltration devices used for purifying, concentrating, dialyzing, and filtering biological samples in the 0–12 mL volume range. These ready-to-use ultrafiltration devices are designed for operation in both centrifuges that have a maximum 3000 rpm centrifuge speed. They can also be used without a centrifuge. The Centriprep® device consists of a sample reservoir with a built-in cup, a filter collector containing a fine ultrafilter (Ultracel®) regenerated cellulose membrane, and an on-rod cap for sample isolation.

The Centriprep® device design allows filtration and fine particle sedimentation to occur at the same time without clogging the membrane. With a Centriprep® 50K device a 10 mL sample can be concentrated to 0.5 mL in just 20 minutes and concentrations of smaller volume samples may take a high concentration factor and a high recovery of the membrane may be achieved, and greater than 90% recovery of retained macromolecules within 20 minutes. A built-in dialysis procedure fluid permeability (water volume of 0.5–0.8 mL).

Required Equipment

Centriprep® devices require the variable speed centrifuge with either a swinging-bucket or fixed-angle rotor and carrier that can properly accommodate 60 mL centrifuge tubes. The centrifuge must be capable of 1000–3,000 x g, for a listing of compatible centrifuges and rotors, see www.millipore.com/centrifuges.

Limitations

With fixed-angle rotors, polarization control may be adversely affected at low g-forces (below 1000 x g). Operating an average concentration procedure with low concentration, filtered flow may be reduced, which may either require additional time and treatment of the filtrate. These limitations may vary by manufacturer. See the manual for details on this device.

Device Storage and Shelf Life

The best results occur with Centriprep® devices at 15–20 °C. Performance may be adversely affected if the device is stored at extreme temperatures (i.e., below 0 °C or above 60 °C). Shelf life is shown below from date of manufacture.

Rinsing Before Use

The appearance of Centriprep® centrifugal filter devices contain trace amounts of glycerol. If this interferes with analysis, fill the device with approximately 10 mL of distilled or deionized water and centrifuge until the first equilibration point is reached. Remove filtrate and concentrate. Repeat as necessary until no more interference is noted. Once each measurement must be kept well to ensure reproducibility.

Membrane and Device Appearance

- Occasionally an unused Centriprep® device may have a few drops of moisture on the filter collector or sample reservoir. This is due to condensation of moisture in the membrane and does not affect performance.
- After centrifugation, a small amount of filter (approximately 0.2 mL) may remain in the trap between the membrane and the membrane support of the Centriprep® device. This is normal and does not affect device operation or performance.
- The Ultracel® membrane used in the Centriprep® centrifugal filter devices may appear slightly wrinkled after spinning.

Centrifugal Filter Device Reset

Centriprep® devices are intended for single-use only. Attempts to clean the device may damage the membrane surface or the seal, possibly compromising the seal integrity and thereby affecting performance.

Principle of Operation

To begin operation, the sample container's built-in cap is loosened and the filter collector is removed. Sample is added, then the filter collector is carefully reinserted back into the sample container (aligning notches and/or markings), sealing the device. The assembled centrifugal filter device is centrifuged at 1,000–3,000 x g, depending on the membrane MWCO used.

Inserting the filter collector into the sample reservoir creates a slight hydrostatic pressure differential that exerts an upward buoyancy force on the membrane at the filter collector bottom. By force, the hydrostatic pressure may delay the upward movement in the small reservoir ultrafiltration. Centrifugation overcomes this pressure, forcing low-molecular-weight molecules and solvent through the membrane into the filtrate collector. Solvent and molecular weight above the membrane (MWCO) remains in the sample container, maintaining a concentration gradient as the operation continues. Ultrafiltration occurs in the device opposite the centrifuge force vector.



The pressure differential created by the solvent solution level is important to centrifugal filter device operation. During centrifugation, the sample solution membrane falls on the filter collector top. In the process, the filter collector falls to the bottom of the sample container, generating maximum filter collector collection. Eventually an equilibrium is reached above the neutral axis at equal heights. Filtration then stops, since the hydrostatic pressure differential is zero.

If further concentration is required, degas the filtrate before spinning the device for a second time. Depending on stabilizing the pressure differential between the sample membrane and the filter collector, allowing filtration to resume. Filtration resumes until a new equilibrium point is achieved. Note that the pressure differential is constantly changing during operation at the neutral axis position.

Centriprep® centrifugal filter devices are designed to maintain high flow rates by minimizing contact points across the membrane during operation. Centrifugal force compresses membrane to 0.25 mm away from the membrane to the sample collector bottom. Because the Centriprep® membrane "floats" above the collection bowl, the full surface of the membrane is used at all times, and flow is unrestricted. This is particularly beneficial when working with suspensions, which can easily clog other filter membranes.
