



FOUNDATION SITE & SOIL

FOUNDATION CONSTRUCTION REQUIREMENTS (Based on IRC 4101.2)

- Foundation construction must be capable of accommodating all loads and of transmitting the resulting loads to the supporting soil.
- Fit soils that support footings and foundations must be designed, installed and tested.

DRAINAGE (Based on IRC 4101.3)

- Surface drainage must be directed to a storm sewer conveyance or other approved point of collection that does not create a hazard.
- Lots must be graded to drain surface water away from foundation walls.
- Grades must fall a min. of 2" within the first 10 ft.

SOIL TESTS (Based on IRC 4101.4)

- Where quantifiable data include expansive soils, compressible soils, settling soils or other questionable soil characteristics, the building official must determine whether to require a soil test.
- In lieu of a complete geotechnical evaluation, assume the values in Table A401.4.1.


FOUNDATION ELEVATION (Based on IRC 4101.5)

- Original elev. the top of any exterior foundation must extend above the structure of the street gutter at point of discharge or the point of an approved drainage device a min. of 2" plus 2%.
- Alternate elevations are permitted subject to the approval of the building official, provided that it can be demonstrated that required drainage to the point of discharge and away from the structure is provided at all locations on the site.

FOUNDATION TYPES

- Applicable to all foundation types.**
- All 3 foundation types rely on perimeter foundation.
 - Grade is the finished ground level adjoining the footing at all exterior walls.
- Slab on Grade Foundations**
- Used mostly in warm climates, where footing is close to the ground and the frost line is close to the surface.
 - In this system the footing is shallow and the ground floor is a concrete slab.
 - Many slab-on-grade systems allow the concrete footing foundation and subfloor to be poured at the same time.
- Crawl Space**
- Crawl Space an under floor space that is not a basement.
 - Found in all climates but predominantly in temperate regions.
 - In this system, the insulated wooden ground floor is supported above grade on a foundation wall made of concrete or concrete block.
- Basements**
- Basement a story that is not a story above grade plane.
 - Used in the coldest part of the country, where frost lines mandate deep footings.
 - Foundation systems are usually constructed of concrete or concrete block (masonry walls).
 - Drainage and waterproofing are used in basement systems.

PRESUMPTIVE LOAD-BEARING VALUES OF FOUNDATION MATERIALS (Based on IRC Table A401.4.1)

- When columns are loaded by Section 4101.4, the allowable bearing capacities of the soil must be part of the foundation design.
- When the building official determines that surface soils with an allowable bearing capacity of less than 1,000 psf are to be present at the site, the allowable bearing capacity must be determined by a soil investigation.

| Expansive soils | Soils that exhibit volumetric increase or decrease (swelling or shrinking) in response to wetting or drying under load. |
