- *tū* = 2nd person singular subject requires the masculine nominative singular participle
- 2nd person singular subject requires = 2nd person singular form of *sum*
- present tense of *sum* indicates the perfect passive, *you have been/were warned.*

3. Equitēs superātī sunt.

The cavalry has been overcome./The cavalry was overcome.

- *equitēs* = 3rd person plural masculine subject requires the masculine nominative plural participle
- 3rd person plural subject requires the 3rd person plural form of *sum*
- present tense of *sum* indicates the perfect passive, *he/she/it has been/was overcome.*

4. Pōns incēnsus est.

The bridge has been burned./The bridge was burned.

- *pōns* = 3rd person singular masculine subject requires the masculine nominative singular participle
- 3rd person singular subject requires the 3rd person singular form of *sum*
- present tense of *sum* indicates the perfect passive, *he has been/was burned.*

5. Frūmentum portātum est.

The grain has been carried./The grain was carried.

- *frūmentum* = 3rd person singular neuter subject requires the neuter nominative singular participle
- 3rd person singular subject requires the 3rd person singular form of *sum*
- present tense of *sum* indicates the perfect passive, *it has been/was carried.*

6. Castra dēfēnsa sunt.

The camp has been defended./The camp was defended.

- *castra* = 3rd person plural neuter subject requires the neuter nominative plural participle
- 3rd person plural subject requires the 3rd person plural form of *sum*
- present tense of *sum* indicates the perfect passive, *they have been/were defended* (but remember we translate *castra* in the singular in English.)

7. Omnia ferē loca occupāta erant.

Nearly all the places had been seized.

- *loca* = 3rd person plural neuter subject requires the neuter nominative plural participle
- 3rd person plural subject requires the 3rd person plural form of *sum*
- imperfect tense of *sum* indicates the pluperfect passive, *they had been seized.*

8. Et pulsī sunt.

They have been pushed back (repulsed)./They were pushed back.

- *ei* = 3rd person plural masculine subject requires the masculine nominative plural participle
- 3rd person plural subject requires the 3rd person plural form of *sum*
- present tense of *sum* indicates the perfect passive, *they have been/were pushed back.*

9. Ductī sumus.

We have been led./We were led.

- "mus" in *sumus* = 1st person plural (masculine because it's plural) subject requires the masculine nominative plural participle
- 1st person plural subject requires the 1st person plural form of *sum*
- present tense of *sum* indicates the perfect passive, *we were/have been led.*

10. Ea gesta sunt.

These things have been waged./These things were waged.

- *ea* = 3rd person plural neuter subject requires the neuter nominative plural participle
- 3rd person plural subject requires the 3rd person plural form of *sum*
